Note 2: AB-54 Edition 1 is in effect until 31 October 2020. Candidates that challenge a fourth class examination prior to 1 November 2017 have until 31 October 2020 to write the second exam that conforms to Edition 1.

Note 3: AB-54 Edition 2 is in effect beginning 1 November 2017. Candidates that challenge their first examination from 1 November 2017 until 31 October 2020 have the option of writing *both* examinations to Edition 1 *or* to Edition 2. However, examinations to Edition 1 will not be offered after 31 October 2020.

Note 4: AB-239 Edition 3 is in effect beginning 1 May 2018. Candidates that challenge their first examination from 1 May 2018 until 31 December 2018 have the option of writing *both* examinations to Edition 2 *or* to Edition 3. However, examinations to Edition 2 will not be offered after 31 December 2018.

Note 5: AB-240 Edition 2 is in effect beginning 1 July 2018. Candidates that challenge their first examination from 1 July 2018 until 31 December 2018 have the option of writing *both* examinations to Edition 1 *or* to Edition 2. However, examinations to Edition 1 will not be offered after 31 December 2018.
